The Actor agrees to:

8. CONFIDENTIALITY

The Actor agrees to keep all project details, story elements, financial terms, and production discussions strictly confidential without prior written consent from the Producer.

9. TERMINATION

This Agreement may be terminated if:

- The Actor's conduct is deemed unprofessional or detrimental to production.
- The Producer cancels the project due to financial or production reasons.
- Both parties mutually agree in writing.

In case of termination, payment shall be proportionate to work completed.
