10. TERMINATION

This Agreement may be terminated by the Producer if the Crew Member:

- Fails to perform duties to the required standard.
- Behaves in a manner detrimental to the production.
- Fails to attend scheduled shoot days without prior notice.



Payment upon termination shall be proportionate to work delivered to date.

11. FORCE MAJEURE

Neither party shall be liable for non-performance due to events beyond their control, including but not limited to natural disasters, government lockdowns, or emergencies.

12. GOVERNING LAW
