- Return all equipment in the same condition as received, with all accessories.
- Report any technical faults or damage immediately to the Owner.
- Be responsible for all consumables (batteries, media cards, etc.) unless otherwise agreed.

7. DAMAGE, LOSS & LIABILITY

- The Renter is fully liable for any loss, theft, or damage to the equipment during the rental period.
- Repair costs shall be borne entirely by the Renter.
- In the event of total loss or irreparable damage, the Renter shall pay the full replacement cost.
- The security deposit shall be applied toward repair or replacement costs.
- The Renter is strongly advised to carry appropriate insurance for all rented equipment.

8. LATE RETURN

- Late Return Fee: Rs. _____ per day beyond agreed return date.

9. INSURANCE
