6. CREDIT

Screen credit is not guaranteed for Extras and Supporting Actors unless specifically agreed in writing.

7. CONDUCT ON SET

The Extra agrees to:

- Follow all direction from the Director, AD, and set management.
- Not use a mobile phone, record footage, or take photographs on set without permission.
- Not approach lead cast or crew unless invited to do so.
- Comply with all safety instructions.

8. CONFIDENTIALITY

The Extra shall not disclose any story details, script content, or production information to any third party or on any social media platform without prior written consent.

9. TERMINATION

The Producer may release the Extra at any time. Compensation shall be for time already worked. Failure to comply with set conduct may result in dismissal without further payment.

10. GOVERNING LAW
