- Restore the location to its original condition after the shoot.
- Comply with all applicable noise, safety, and local regulations.
- Not exceed the agreed crew size or access times without written consent.
- Obtain any required permits or permissions from local authorities.

7. DAMAGE & LIABILITY

- The Producer shall be fully liable for any damage caused to the property during the shoot.
- The Producer shall carry public liability insurance covering the shoot.
- The Location Owner shall not be liable for any injury, loss, or damage suffered by the production crew on the premises.
