- Arrive at least 90 minutes before the first scheduled shot.
- Carry all necessary products, tools, and materials as required.
- Perform touch-ups throughout the shoot day as needed.
- Liaise with the Director and Costume Designer to ensure visual consistency.

7. RIGHTS & PORTFOLIO USE

- The Producer grants the Artist permission to use behind-the-scenes images for portfolio purposes, subject to prior written approval.
- The Artist may not share any production content publicly before the official release date.

8. HEALTH, SAFETY & HYGIENE

The Artist agrees to:

- Maintain the highest standards of hygiene and sanitisation.
- Use hypoallergenic or approved products unless the cast member agrees otherwise.
- Inform the Producer immediately of any allergic reactions or health concerns.
- Comply with all set safety protocols.

9. CONFIDENTIALITY

The Artist shall keep all project details, cast information, and financial terms confidential both during and after the production period.

10. TERMINATION

Either party may terminate this Agreement with 48 hours written notice. Payment shall be proportionate to services already rendered.

11. FORCE MAJEURE

Neither party shall be liable for non-performance due to events beyond their control, including natural disasters, government restrictions, or emergencies.
