8. ORIGINALITY CLAUSE

The Writer guarantees that:

1. The submitted work is original.
 2. It does not infringe upon any copyright, trademark, or intellectual property rights of any third party.
 3. In case of any legal claim arising from plagiarism, the Writer shall be responsible.

9. TERMINATION

This Agreement may be terminated if:

1. The Writer fails to deliver the agreed work within the deadline.
2. The Producer cancels the project due to financial or production reasons.
3. Both parties mutually agree in writing.

In case of termination, payment shall be made proportionate to completed work.
